

IT IS HEREBY ORDERED, ADJUDGED AND DECREED that Peoples Bank & Trust have judgment against Gerritt Van Beek and Fonda Van Beek, jointly and severally, for the sum of Ten Thousand Dollars (\$10,000.00). Pursuant to agreement of the parties, Peoples Bank & Trust, Rock Valley, Iowa, shall not seek execution upon such judgment unless there be default by Van Beeks or either of them in the payment of the judgment as set out herein. Van Beeks shall pay to Peoples Bank & Trust at Rock Valley, Iowa, the sum of \$200.00 per month for fifty (50) months beginning January 2, 1987 and continuing each 2nd of the month thereafter until such judgment is fully paid. The judgment amount of Ten Thousand Dollars (\$10,000.00) shall not bear interest unless there is default by Van Beeks in the payment described herein. If there is default, the remaining balance of such judgment at the time of default shall bear interest at the rate of 10% per annum from the date of default. If there is default, Peoples

Bank & Trust shall be free to seek execution against Van Beeks or either of them to satisfy any remaining balance of the judgment in full. This judgment is non-dischargeable under 11 USC Section 523(a)(6).

IT IS ORDERED on this 15<sup>th</sup> day of December, 1986.
