ORDER RE: STIPULATION OF SETTLEMENT


The parties to this adversary proceeding filed a Stipulation of Settlement on June 7, 1991. Plaintiff filed a Dismissal with Prejudice on June 7, 1991. By order of June 14, 1991, this court required the stipulation to be served by the parties upon the U. S. Trustee and the case trustee. The court's order gave those parties-in-interest ten days from service to object to the settlement. Time has passed for objection, and no objections have been filed. The court has examined the Stipulation of Settlement and finds it should be approved. Accordingly,

IT IS ORDERED that the Stipulation of Settlement filed June 7, 1991 is approved. Judgment shall enter that plaintiff, Farmers State Bank, shall recover from defendant, Mark Allen Hinnners, the sum of \$125,000.00. This judgment is excepted from discharge in bankruptcy.

IT IS FURTHER ORDERED that defendant shall furnish to plaintiff a copy of his tax returns and supporting documents, when prepared, for the next ten years, starting with the 1991 returns.

IT IS FURTHER ORDERED that the Motion to Dismiss is denied.
