
STIPULATION FOR AND ENTRY OF JUDGMENT







The issues of this proceeding having been duly considered by the Honorable WILLIAM L. EDMONDS, United States Bankruptcy Judge, and a decision having been reached without trial or hearing.

IT IS ORDERED AND ADJUDGED:

that the Complaint herein of Karen Louise Scholl is dismissed as to the University of Iowa; Higher Education Assistance Foundation; Firststar Bank, Cedar Rapids, N.A.; and Sallie Mae Loan Servicing Center.

IT IS FURTHER ORDERED AND ADJUDGED that judgment in favor of defendant University of Iowa be entered against plaintiff Karen Louise Scholl in the sum of \$600.00, plus interest at 5 percent per annum from February 26, 1992, plus the costs of this action taxed by the clerk. No execution shall issue upon this judgment during the period which the plaintiff faithfully pays directly to the University of Iowa the sum of \$20.00 per month, commencing on the 15th day of November, 1992, (10-day grace period), and continuing thereafter on the 15th day of each month until the entire principal balance and court costs have been paid in full. Proof of default by the plaintiff shall be made by the filing of an affidavit by the defendant herein as to the defaults of the plaintiff, specifying them, and upon the filing of such an affidavit of default, execution may issue at any time, without further notice, upon the request of the defendant.
