ORDER RE: TRIAL


The trial of the dischargeability complaint filed by the plaintiff was held on August 21, 1991. The plaintiff, Shannon Beard appeared pro se. The defendant appeared personally together with his attorney Stephen Rapp.


The Court, having heard the evidence and having considered the arguments of the parties, entered findings of fact, conclusions of law, and order on the record. The Court found that the defendant owed to the plaintiff a nondischargeable debt in the total amount of \$1,296. In addition, court costs in the total amount of \$120 will be assessed against the defendant.

IT IS THEREFORE ORDERED that a judgment shall enter in favor of the plaintiff and against the defendant for a nondischargeable debt pursuant to 11 U.S.C. § 523(a)(6) in the total sum of \$1,296. The Clerk shall also assess court costs against the defendant in the

total amount of \$120.
