THIS matter comes to the Courts attention upon the Trustee's Notice and Report of Sale of Property and the Court having read the record and being duly advised in the premises finds:


1. That the undersigned is the duly acting and appointed Trustee in the above captioned matter.

to South Sioux City, Nebraska


