The Complaint of James K. Nanninga and Rae L. Nanninga, seeking determination of the dischargeability of its debt against Roger L. Paulson, comes on before this Court. The Court having reviewed the file, having been advised that the Plaintiff and Defendant/Debtor have reached a compromise as to the disposition of this adversary action, and that the Defendant/Debtor has approved this judgment as to form. It is therefore appropriate that the judgment as set forth below should be entered.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that \$7,400.00 of the debt of Roger L. Paulson to James K. Nanninga and Rae L. Nanninga is hereby determined to be non-dischargeable under the provisions of §523 of the Bankruptcy Code.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that James K. Nanninga and Rae L. Nanninga have and recover judgment against Roger L. Paulson for the principal sum of \$7,400.00, together with interest at six percent (6%) per annum, from and after January 1, 1993.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that all other indebtedness of Roger L. Paulson is determined to be dischargeable.
