IT IS THEREFORE ORDERED that the Complaint herein of Plaintiffs Timothy C. Bell and Sandra K. Bell is dismissed.



Defendant HEAF is ordered to withhold from attempting any collection activities on the judgment as long as Plaintiffs pay the sum of \$50.00 per month, beginning July 1, 1992, and continuing on the first of every month thereafter until the entire judgment, plus interest, collection fees and costs are paid.
