
IT IS THEREFORE ORDERED that the Complaint herein of plaintiff Angela Susan Goesse is dismissed as to the intervener Iowa College Student Aid Commission.


IT IS FURTHER ORDERED that judgment in favor of intervener Iowa College Student Aid Commission be entered against plaintiff Angela Susan Goesse in the negotiated sum of \$2,184.32, plus interest at 0 percent for 24 months from date of entry of this judgment, and thereafter at 8 percent per annum until paid. No execution shall issue upon this judgment during the period which the plaintiff faithfully pays directly to the Iowa College Student Aid Commission the sum of \$50.00 per month, commencing on the 1st day of May, 1994, (10 day grace period), and continuing thereafter on the 1st day of each month until the entire principal balance, plus accrued interest has been paid in full. Proof of default by the plaintiff shall be made by the filing of an affidavit by the intervener herein as to the defaults of the plaintiff, specifying them, and upon the filing of such an affidavit of default, execution may issue at any time, without further notice, upon the request of the intervener.


