
ORDER RE: STIPULATION FOR ENTRY OF JUDGMENT

The parties have filed a stipulation for entry of judgment. The stipulation and settlement provides for the entry of a nondischargeable judgment in favor of plaintiff and against defendant on the plaintiff's claim under 11 U.S.C. § 523. It provides for dismissal of the claim under 11 U.S.C. § 727. Pursuant to the local rules and Fed.R.Bankr.P. 7041, the stipulation and affidavit of consideration were served on the case trustee, U. S. Trustee, and counsel for the debtors.

IT IS ORDERED that the stipulation is approved.

IT IS FURTHER ORDERED that judgment shall enter that Clark Credit Corporation shall recover from Russell James Woodward the sum of \$1,500.00. This judgment is nondischargeable pursuant to 11 U.S.C. § 523(a)(3). Plaintiff's claim under 11 U.S.C. § 727 is dismissed. Judgment shall enter accordingly.
