The Court hereby overrules the objection filed by Michael Simmons, Publisher of MPC Newspapers.


WHEREFORE, it is hereby ordered, adjudged, and decreed that a nondischargeable judgment pursuant to 11 U.S.C. §523(a)(2) in the amount of \$117,887 shall be entered against Donald C. 
