
The court has been informed of subsequent settlement discussions between the parties. Counsel for plaintiff, accordingly, now requests permission to dismiss plaintiff's Complaint. Counsel to defendant University of Iowa has no objection to the dismissal.

IT IS THEREFORE ORDERED that the Complaint herein of plaintiff Tonya J. Thul is dismissed as to defendant University of Iowa.


IT IS FURTHER ORDERED that judgment in favor defendant University of Iowa be entered against plaintiff Tonya J. Thul in the negotiated sum of \$1,887.00, without interest. No execution shall issue upon this judgment during the period which the plaintiff faithfully pays directly to the University of Iowa, Student Loan Accounting, Rm. 5 Calvin Hall, Iowa City, Iowa, 52242-1315, Attention Jennifer Kooker, the sum of \$36.00 per month, commencing on the 15th day of the first full month after date of entry of this Order, (10 day grace period), and continuing thereafter on the fifteenth day of each month until the entire negotiated sum has been paid in full. There shall be a late payment penalty of \$4.00. Proof of default by the plaintiff shall be made by the filing of an affidavit by the defendant herein as to the defaults of the plaintiff, specifying them, and upon the filing of such an affidavit of default,

execution may issue at any time, without further notice, upon the request of the defendant.


