ORDER RE: MOTION FOR DEFAULT JUDGMENT

On February 15, 1995, the Trustee filed a complaint against defendant Denis Della Vedova, Inc. The Trustee alleged that defendant owed \$13,500.00 to debtor The Paving Company, Inc. on open account. The Trustee certified that copies of the summons and complaint were served on the defendant on February 22, 1995. Defendant has failed to plead or otherwise defend the complaint, and the time for doing so has expired. The Trustee now moves for entry of default judgment. The court concludes that judgment should enter against defendant.

IT IS ORDERED that the Trustee's motion for default judgment is granted. Plaintiff Habbo G. Fokkena shall recover from Denis Della Vedova, Inc. the sum of \$13,500.00. Costs shall be taxed to defendant. Judgment shall enter accordingly.


