
ORDER OF NON-DISCHARGEABILITY OF DEBTS

The above-captioned matter came before the Court on Plaintiff's Complaint as to Dischargeability of Debts filed November 13, 1995. Thereafter, the Debtor/Defendant, John Edward Heathershaw, through his attorney, filed an Answer to Complaint as to Dischargeability of Debts in which Defendant admitted all of the allegations set forth in Plaintiff's Complaint and stated Defendant did not contest the relief prayed for by Plaintiff. This Court therefore FINDS that the allegations as set forth in Plaintiff's Complaint are material and true and that Plaintiff is entitled to the relief requested in her Petition.

IT IS THEREFORE ORDERED that Plaintiff's Complaint is granted in its entirety and Debtor/Defendant, John Edward Heathershaw is hereby denied the dischargeability of said debts, pursuant to Section 523(a)(5) and/or (15) of the Bankruptcy Code, which debts said Debtor/Defendant, John Edward Heathershaw, was ordered to pay pursuant to an Order, Judgment and Decree entered July 6, 1995, in Black Hawk County, Iowa, District Court, Black Hawk County Equity No. CDDM040057, including \$1,000 of Plaintiff's attorney fees and court costs in the amount of \$45.00, to be paid by Defendant, all of which debts are hereby deemed to be non-dischargeable in Defendant's Chapter 7 bankruptcy action, Case No. 95-61527 KW.

IT IS FURTHER ORDERED that the costs of this adversary proceeding are taxed to the Defendant, John Edward Heathershaw, and judgment is accordingly entered against him in the sum of \$ 120.00.
