Plaintiff Terril Community School District and defendant Louise E. Hales have entered into and filed a stipulation resolving this adversary proceeding between them (docket no. 16).

The stipulations fully resolve this adversary proceeding. In accordance with the stipulations of the parties,

IT IS ORDERED that judgment shall enter that Employers Mutual Casualty Co. shall recover from Louise E. Hales the sum of \$90,000.00. This judgment is excepted from debtor's discharge pursuant to 11 U.S.C. § 523.

IT IS FURTHER ORDERED that judgment shall enter that Terril Community School District shall recover from Louise E. Hales the sum of \$7,000.00. This judgment is excepted from debtor's discharge pursuant to § 523(a)(4). The defendant may satisfy

this judgment in accordance with the terms set forth in  
"Stipulation Regarding Restitution and Repayment" filed in  
Criminal No. 9486, Iowa District Court for Dickinson County.

IT IS ORDERED that the clerk shall enter separate judgments  
for each plaintiff.
