On March 26, 2009, the Supreme Court of the United States approved amendments to 39 Federal Rules of Bankruptcy Procedure, designed to remove inconsistency and unnecessary complications associated with the computation of time periods driven by the rules. On May 7, 2009, the President signed into public law (Public Law No. 111-016), amendments to 28 statutes, including sections of the Bankruptcy Code, also to clarify computation of time periods driven by these statutes. The amendments to the Rules and Code shall become effective on December 1, 2009.

THEREFORE IT IS HEREBY ORDERED that, pursuant to 28 U.S.C. section 2071, Rule 83 of the Federal Rules of Civil Procedure and Rule 9029 of the Federal Rules of Bankruptcy Procedure, EFFECTIVE DECEMBER 1, 2009;
