ORDER RE: ATTORNEY FOR DEBTORS' INTERIM FEE APPLICATION

The matter before the court is the interim application filed by John Harmelink, Esq. seeking professional compensation for work done as debtors' attorney. The interim application was filed July 27, 1995 and amended August 14. State Bank of Alcester objects to the fees. Hearing was held October 5, 1995. John Harmelink appeared as applicant and for debtors; Richard H. Moeller, Esq. appeared for Bank.

Gerald and Judith Johnson filed their joint chapter 13 petition on March 27, 1995. They paid Attorney Harmelink a retainer of \$1,000.00 prior to filing and \$100.00 during the case. Harmelink was to charge Johnsons \$100.00 per hour, but with their agreement that they would pay him any subsequent increases in his regular hourly rate. For work done after May 19, 1995, Harmelink raised his hourly rate to \$125.00.

Johnsons first contacted Harmelink for legal services on August 12, 1994. They discussed financial matters. They met again four days later to discuss filing bankruptcy. However, much of the work done prior to the filing of their chapter 13 petition appears to have involved disputes and litigation with the State Bank of Alcester. Because much of the pre-petition work was distant in time from the filing and related to litigation and not to bankruptcy, the court will not allow administrative compensation as part of the bankruptcy case. The court will allow compensation for pre-petition work totaling 4.75 hours and \$475.00 relating to the following dates: 8/12/94, 8/16/94, 8/30/94, 9/6/94, 9/27/94, 10/11/94, and 2/7/95. For legal work done after March 27, 1995, the court will allow compensation at the rates requested with one exception. On June 12, 1995, Attorney Harmelink spent one hour working on a motion to continue a valuation hearing scheduled for June 27, 1995. The conflict was due to his schedule, not his clients'. He should not bill his clients for such work. Post-petition work totaling 22.41 hours valued at \$2,356.25 will be allowed. The total interim allowance for bankruptcy work is \$2,831.25. Mr. Harmelink requests reimbursement of actual, necessary expenses in the amount of \$496.27. The court will disallow those pre-petition expenses which do not appear to have related to the chapter 13 filing:

The court will also disallow the expenses relating to the copying and services of the motion to continue in the amount of \$9.01. Disallowed expenses total \$51.82. Allowed expenses total \$444.45. The court will allow interim fees and expenses totaling \$3,275.70. Attorney Harmelink may apply the \$1,100.00 in his trust account to the interim allowance. Such application leaves unpaid allowed interim fees and expenses of \$2,175.70. Compensation of that amount must await confirmation of a plan. If Attorney Harmelink seeks immediate payment of that amount, he may seek a hearing with notice to the chapter 13 standing trustee, the U.S. Trustee and counsel for State Bank of Alcester.

IT IS ORDERED that John Harmelink attorney for debtors, is allowed interim professional compensation and reimbursed expenses in the amount of \$3,275.70. He may apply \$1,100.00 held in his trust account to the interim allowance. Payment of the remaining interim allowance may be made only on further order of this court.
